This was a year of change and gratitude. In recognition of his extraordinary legacy of public service, **Mr. Tung Chee-hwa** was elected Chairman Emeritus of the nonprofit he founded with his visionary leadership in 2008.

Mr. John Zhao was elected Chairman and Mr. Andy Tung was elected Vice Chairman serving with Dr. Victor Fung, our founding Vice Chairman. Meanwhile, I was deeply honored to be appointed President. More than ever, we are committed to a future where China and the U.S. shape the world for the better.

In the past year, I've witnessed the profound impact of our work:

First, we achieved a rare expression of global unity, when our annual meeting in November 2023 was opened by Ambassador Xie Feng, Ambassador Nicholas Burns, and President José Ramos-Horta who won the Nobel Peace Prize.

Second, we supported a dialogue between retired generals and admirals that resulted in a restart of military communications — a headline news story announced by President Xi Jinping and President Joe Biden in a joint statement.

And third, we became the first organization to bring a U.S. student delegation to China, after the leaders of the two countries made a commitment to increase educational exchanges during the APEC meeting in California.

In this decisive moment the world needs more, not less, human connectivity. That is why I am calling on each of you — our invaluable donors and partners — to join in our shared mission.

Fifteen years after Mr. Tung Chee-hwa created CUSEF, I invite you to write the next chapter of our story and create a peaceful and prosperous world.

With your trust and partnership, I am confident that the best days for our children and grandchildren lie ahead.

May I reserve a last word to honor two individuals: **Dr. Henry Kissinger** (1923-2023) who served as our Honorary Advisor from our establishment until his passing; and **Mrs. Rosalynn Carter** (1927-2023) who co-founded The Carter Center, our esteemed partner.


1. OUR MISSION

Historically Black Colleges and Universities in the U.S. We support different and high-caliber opinions, and work to ensure that financial cost is not a barrier to participation in our programs.












3. OUR STORY

We are positioned along the renowned Victoria Harbor that was first referenced in 1425 on sailing maps drawn by Chinese explorer, Admiral Zheng He. Over the centuries, its natural protection from wind and waves have provided a sanctuary for passing vessels.

4. OUR LEADERSHIP

CUSEF was established in 2008 by Mr. Tung Chee-hwa, a leader in the global shipping industry who was elected the first-ever Chief Executive of Hong Kong in 1997. He believes in the promise and potential of China and the U.S.

— to unlock peace and prosperity, and accelerate progress for the human condition.

Our governance is guided by an eminent board led by Mr. John Zhao, Dr. Victor Fung, and Mr. Andy Tung. The executive team is headed by Mr. James Chau, an international journalist and World Health Organization Goodwill Ambassador.

Mr. Tung was Chairman and Chief Executive Officer of the family shipping business Orient Overseas (International) Limited (OOIL), before becoming Chief Executive of the Hong Kong Special Administrative Region at the Handover in 1997. He later served as Vice Chairman of the National Committee of the Chinese People's Political Consultative Conference, People's Republic of China. He also established the Our Hong Kong Foundation.

Mr. Zhao is Chairman of Hony Capital, an investment management group focusing on Greater China's economic development opportunities. He currently serves as a board member on several multinational companies, non-profit organizations, and public institutions. 



5. OUR PROGRAMS

Year-round, we offer imaginative programs that appeal to a broad range of constituents: from high-level political leadership to scholars and business figures, to students from high schools and universities.

We support, with the Henry Luce Foundation, the U.S.-China Scholarly Exchange led by Professor Wang Jisi at Peking University and Scott Kennedy from the Center for Strategic and International Studies. We also organize private roundtables with speakers from peer organizations.

This builds on our tradition in upholding research and scholarship, dating back to 2013, when we released a ten-year study on economic bilateral ties. Led by Mr. Tung Chee-hwa, the publication was supported by CUSEF's Mr. John Zhao, Dr. Victor Fung and Professor Lawrence Lau, and winner of the Nobel Prize for Economics Professor Michael Spence. American steering committee members included Ajay Banga, Bill Gates, Maurice Greenberg, Indra Nooyi, John Podesta, and David Rubenstein.

Notably, we are established partners of the Sanya Initiative, also known as the U.S.-China Military-to-Military Dialogue. The annual closed-door discussion gathers retired four-star generals and naval admirals from the U.S. and their Chinese equivalents. This is a critical framework in uncertain times for international security.

We are also a recognized convenor of the U.S.-China High-Level Political Party Leaders Dialogue, a platform for senior representatives from the Democratic Party, Republican Party, and Communist Party of China. Delegates have included U.S. Secretary of State Madeleine Albright, Chinese State Councilor Yang Jiechi, as well as U.S. Ambassador and Senator Max Baucus.

We create short videos in partnership with Art Basel, the world's most renowned art fair, and we sponsor milestone events such as the 50th anniversary celebrations of Ping Pong Diplomacy that opened the way for political rapprochement.

In particular, we are known for organizing monthly student exchanges for global universities. Since our first delegation ten years ago, over 2000 youth have experienced this program. Some 40% of these exceptional students are selected from Historically Black Colleges and Universities (HBCUs) — many of whom also enrolled in our three-month virtual Putonghua language course during the pandemic.

Deniz Aycan, a second-year Master's student at the University of Chicago's Harris School of Public Policy, testified to the impact of the CUSEF exchange as "an opportunity to familiarize myself with high-level Chinese policymaking." Chinese participants such as Yu Duhao, who is enrolled at Fudan University in Shanghai, also remarked on the unique space to "engage in dialogue and network with young leaders at top American universities."

We champion the role of teaching, research, and learning by supporting or co-hosting academic conferences at Peking University, Columbia University, and the annual China Conference at Harvard Kennedy School, among others. These events draw top thinkers such as Professor Graham Allison, Professor Xue Lan, and Olympic champion Eileen Gu.

We track our impact against the delivery of the Sustainable Development Goals, a universal mandate adopted by all United Nations Member States. It provides a shared blueprint for peace and prosperity for people and the planet.




In 2019, we created The China Current, a groundbreaking platform for short videos and podcasts about Chinese lives in the 21st century.

It is hosted by James Chau, American environmental photographer Kyle Obermann, and British concert violinist Tasmin Little who was recently honored by King Charles III. The China Current continues to evolve into a multimedia platform with global impact, striving to offer ideas and solutions to our greatest challenges such as poverty, climate change, health, and innovation.

Today we have over 1 million followers on Facebook, YouTube, and Twitter — and we are the premier storytelling experience of its kind.



















Books and Documentaries

Jane Goodall, a global expert on chimpanzees; Muhammad Yunus, winner of the Nobel Peace Prize; and Vanessa Kerry, founder of Seed Global Health, have been interviewed by The China Current. They also feature in our book *New Tomorrow*.

This collection of conversations also includes Peter Piot, Mary Robinson, Kishore Mahbubani, Rajiv Shah, Erna Solberg, He Yafei, Thomas Bach, Margaret Chan, Helen Clark, Jeffrey Sachs, Filippo Grandi, and Tedros Adhanom Ghebreyesus.



From short videos, we have expanded into feature length documentaries.

Our debut film production tells the story of the Shanghai Jews, who survived the Holocaust in Nazi Europe by escaping to China during the Second World War.

At least 18,000 refugees from Germany, Austria, and elsewhere in Europe, are known to have lived — many with the help of Dr. Ho Feng-shan, a Chinese diplomat who issued thousands of visas.

End of the Earth: The Journey of the Shanghai Jews is scheduled for U.S. release in 2024.

We convene conversations and share them near and far. That is the role of our digital platforms where everyone can access and watch our videos and podcasts.







U.S.-China Hong Kong Forum

Our landmark event is the U.S.-China Hong Kong Forum. This is CUSEF's annual meeting, bringing a focus to major issues such as the economy, international security, artificial intelligence, and people-to-people diplomacy.

Since its first edition in 2019, it has emerged as a leading global conference, supported by a coalition of heads of state and government: José Ramos Horta, Mary Robinson, Yasuo Fukuda, Helen Clark, Romano Prodi, Goh Chok Tong, and Jean Chrétien. It has also been attended by senior figures from the United Nations.

The meeting is co-organized by CUSEF and the China Center for International Economic Exchanges, a State Council think-tank founded by former Vice Premier of the People's Republic of China Mr. Zeng Peiyan, and chaired by former Commissioner of the China Food and Drug Administration Mr. Bi Jingquan.




